NARRATIVE

On June 30, 2021, at approximately 8: 40 pm, I, Officer, C. Miller unit 3610, responded to a call, 403 Moreland ave SE. Upon my arrival, I was met with Fire Engine 13, Grady unit 607, Officer, A.B. Miller, unit 3608, Officer, R. McIntyre unit 3607, Sgt. D. Simmons unit 3696, Lt. D. Floyd unit 3691, Ms. Cormya Baker and Mr. Arnold Terrell. Ms. Baker reported to me, she was in the front right passenger seat of Mr. Terrell's vehicle. Ms. Baker advised, they were traveling Eastbound on I-20 expressway, in the HOV lane, a orange new model Kia Forte was seen driving in the right lane next to them. The vehicle then changed lanes, entering Mr. Terrell's lane of travel, pulling out in front of them. Mr. Terrell and Ms. Baker stated they heard the noise of the glass cracking to their vehicle's windshield, Ms. Baker, noticed she was bleeding from her upper right side of the chest. Mr. Terrell advised he pulled off on to the nearest exit and into a parking lot. Ms. Baker had discovered a projectile in the front right passenger seat. Both Mr. Terrell and Ms. Baker reported, they were unable to retrieve a tag of the orange Kia, they were unable to get a description of the driver, and stated they never saw a firearm, no hands outside of suspects vehicle, they just heard a loud noise from their vehicle's windshield being cracked. Mr. Terrell was not injured, Ms. Baker displayed slight injury to her upper right chest and was transported to Grady Hospital. CIU Inv. Hernandez unit 5646, and Sgt. Moody 5606, Aggravated Assault Inv. Walley unit 4329 Crime Scene Officer, Traugott unit 7308 were advised and arrived on scene. Crime Scene Officer, collected the projectile Media arrived on scene. Radio was advised, and a lookout was put out on air for a orange Kia Forte traveling Eastbound on I-20 expressway. Video footage may be possible for recovery at Cookout restaurant, Corporate number (336) 313-5226 for access. Mr. Terrell advised he was coming from the airport, and was heading to Ms. Bakers new apartment in Atlanta. Mr. Terrell and Ms. Baker were given case numbers for their report. Mr. Terrell was left in possession of his vehicle. Nothing further to report.
