Mr. Torrence stated, he was going home and just got off work. Mr. Torrence stated, once he started traveling south on Parkway Dr Ne, he heard shots fired and immediately sped away on a E Bird scooter. Mr. Torrence stated, he realized he was shot and went straight to the Atlanta Medical hospital.

I canvassed the intersection of Parkway Dr Ne & Felton Dr Ne and observed reddish brown stains that resembled blood on the sidewalk near 552 Parkway Dr. Officer Rodgers spotted a shell casing on the sidewalk in front of the Bedford Pines Apartment staircase at 552 Parkway Dr. A total of 7 shell casings where recovered at the location.

The suspect waits for Mr. Torrence to ride by him a E Bird scooter at approximately 4:05 pm and without notice or instigation, the suspect fires 7 shots at Mr. Torrence. The suspect retreats into apartment 101 at 552 Parkway Dr Ne. The suspect later comes back outside and enters a white in color 2002 Chevy Impala with tinted windows (No Tag). That vehicle travels North Bound on Parkway Dr Ne.

Mr. Torrence stated, he did not recognized the suspect that shot him, however he informed Ofc. Butler that the suspect had short dreads.

Video footage was sent to GAT Investigator 4340 email. GAT INV 4340 arrived on scene for further investigation as well as SGT. Egbert. Crime Scene 7334 arrived on scene and recovered shell casings and other pivotal evidence.
