NARRATIVE

On June 26, 2021, I (Ofc. K. Spence, Unit 2210, Vehicle 34722) was dispatched to larceny call located at 3391 Peachtree Rd at the Westin Room #919.

Upon arrival, I made contact with Bleus Samuel (D.O.B. [REDACTED]/81). Mr. Samuel advised he met a woman that gave the name "Sasha" at Hide Kitchen & Cocktails located at 3186 Roswell Rd. Mr. Samael stated after meeting "Sasha" they left the location and went to Tattletale Lounge located at 2075 Piedmont Rd. They stayed for approximately an hour. Mr. Samuel advised he then took "Sasha" back to his room at the Westin. Mr. Samuel advised he secured his jewelry valued at approximately one million dollars in the room safe and locked it. Mr. Samuels advised the two then had sex, he stated he believes he might have been drugged by "Sasha". He stated since he has never slept that hard. When Mr. Samuels woke up "Sasha" was not in bed and the shower was running. When he went to the bathroom it was empty and his safe was open. All his jewelry was stolen from the safe. The front door to the room was also left unlocked. Mr. Samuel advised he is not sure how she was able to unlock the safe and he is positive he locked it.

After speaking to Mr. Samuel, I spoke with hotel security. Security stated they have footage of Mr. Samuel and the suspect at the lobby at approximately 0300 hours 6/26/21. They also advised Mr. Samuel s room was opened at approximately 0508 hours 6/26/21 and never secured until Mr. Samuel exited the room. I advised Supervisor (Sgt. Stevenson) and Zone CID (Inv. Cunningham) on my call. Inv. Cunningham recognized the similarities in my case with one of his on going investigations. Inv. Cunningham came out to the scene and presented a photo line up to Mr. Samuels. Mr. Samuel identified Shirley Acambuya (D.O.B. [REDACTED]/97) as the woman he met a Hide Kitchen. Mr. Samuel s positive identification confirmed her relation to Inv. Cunningham s other cases. Crime Scene 7307 (A. Green) processed the and collected the sheet set and a towel that Mr. Samuel advised the suspect used. I have attached video evidence of the items stolen provided by Mr. Samuel. Mr. Samuel s was advised to gather documentation to prove value of the items stolen.
