NARRATIVE

On 12/23/2021 I Officer R. Lockhart of unit 3701 along with unit #3703 Officer F. Shelly of unit #3703, Officer G. Davis of unit #3705 and V. Mack of unit #3702 responded to a fight that took place during a Delta flight from Tampa, FL to Atlanta, GA (Delta flight #2790). While on scene I was able to make contact with BENTON, PARIS with Delta Airlines.

While waiting for the aircraft to arrive to the gate Ms. Benton stated that she received information in regards to a female passenger acting disorderly, interfering with flight crew along with attacking passengers and flight crew. After obtaining this information the aircraft arrived to the gate. During the de-boarding processes I was able to obtain witness statement from passenger CAMPBELL, SONYA, CHENAULT, CLARISSA who was a passenger burned by hot water because of the suspect's disruptive actions, MILLER, RUSSELL stated that he was punched in the face and scratched on his face eye area by the suspect

(a), Delta flight attendant YUBETA, CODY stated that he attempted to restrain the suspect while she attempted to kick him

(b), DELGADO, AMILCAR stated that he was a passenger that help restrained the suspect

(c), and Delta flight attendant

The suspect who was later identified as CORNWALL, PATRICIA of Los Angeles California was detained by Atlanta police and transported to the Domestic precinct. After advising on-Call FBI agent R. JARRARD of the incident he arrived to the Atlanta police domestic precinct to take custody of Ms. Cornwall because of the incident taking place in the air on board an aircraft.

). Video of the incident was shared by Ms. Chenault.

Ms. Cornwall was charged with assault on a federal level and transported by FBI agents to a detainment facility for further investigation.
